Student Transfer Form For 2021-2022 Parent and Guardian Instructions



Banquete Independent School District has made a commitment to quality schools which depends much upon a shared commitment by our students and parents who want to participate in our positive learning environment. For applicants seeking to transfer into BISD from another school district, it is particularly important that both the student and parent join in this commitment because, for transfer students, ***attending Banquete ISD is not a right, it is a privilege.***

Texas law permits any child, other than a high school graduate, who is younger than 21 years of age and eligible for enrollment on September 1st of any school year to transfer annually from the child's school district of residence to Banquete ISD **ONLY** if both Banquete ISD and the applicant parent or guardian or person having lawful control of the child jointly approve and timely agree to the transfer.

By law, the Banquete ISD or the BISD Board of Trustees are not required to admit a child if:

- *Student DID NOT demonstrate mastery on all sections of the most recent State of Texas Assessment of Academic Readiness (STAAR/EOC)*
- *Student engaged in conduct or misbehavior within the preceding year that has resulted in:*
 - *Removal to a disciplinary alternative education program; or*
 - *Expulsion*
- *Student engaged in delinquent conduct or conduct in need of supervision and is on probation or other conditional release for that conduct; or*
- *Student has been convicted of a criminal offense and is on probation or other conditional release.*
- *Admission of the student would cause over-crowding of classes*
- *Admission of the student would cause the District to hire additional personnel*

The District Transfer Required Standards are listed below:

- *Must attend Face-to-Face Instruction*
- *1ST Year Student transfer student –*
 - High School students will follow the UIL Academic & Athletic guidelines and be approved and enrolled at the beginning of the 4th six weeks in order to try out for cheerleader*
 - Jr High students will follow UIL Academic & Athletic guidelines and must be approved and enrolled at the beginning of the 4th six weeks in order to be eligible to participate in district team sports or tryout for cheerleader.*
- *Must have met the 90% attendance requirement*
- *Must have passed all state assessment test which apply to student in his/her most recent school year*
- *Must have good grades and have been promoted to the next grade level*
- *Must have good discipline records*
- *Must not be in need of supervision or on probation*
- *Must not have been assigned to DAEP*

Banquete ISD evaluates the conduct of all transfer students annually and will not accept student transfer after March 11, 2022. Transfer students who demonstrate conduct which is not in compliance with Banquete ISD School Student Code of Conduct, UIL Rules and Regulations, and BISD Campus and Athletic standards during the approved school year **will be revoked**. If admitted, transfer student's parent or guardian will be responsible for the child's transportation to Banquete ISD.

In return for the district permitting my student to transfer into Banquete ISD, I expressly waive and release any claim that I may have that the district cannot revoke a transfer, and/or that the transfer of my student must be for a period of one year. By my signature below, I expressly confirm that I agree with and accept all of the reasons for a transfer revocation set out in the non-resident transfer agreement, and further agree that this agreement can be revoked for any of those reasons before the end of the school year for which the transfer is approved.
