- Revise the following sections:
 - Section 3.1 on page 9 of 19 to read “Firms submitting statement of qualifications must be represented by a professional Architect and/or a Professional Engineer licensed to practice in the State of Texas and able to provide a Professional Architect and/or a Professional Engineer to attend meetings of any official nature concerning the project, including but not limited to qualifications, Scope Meetings, Review Meetings and other meeting as may be required for the project Administration through final acceptance of the completed project.”
 - Section 3.2.1 on page 9 of 19 to read “Demonstrated firm experience in functional design of high quality and cost-effective new construction, renovation, MEP projects, and/or retrofit in School Districts and other similar projects. Strong background in contract management, facility assessment, cost estimation, obtaining necessary permits, coordination with local agencies/authorities and public involvement. Experience with CSP and CMAR delivery methods or other methods applicable under Texas Gov’t Code 2269.”
